## Engagement and Remedy Forum for Responsible Business Conduct 2021

In December 2019, the “[Engagement & Remedy Guidelines](#)” was published by the Global Compact Network Japan (GCNJ) and the Business and Human Rights Lawyers Network Japan (BHR Lawyers). The aim of the Guidelines is to promote a constructive dialogue between business enterprises and the society, to enhance grievance mechanisms, and to ensure access to remedy. As a launch event, the Symposium “[Towards Promotion of Responsible Business Conduct and Supply Chains](#)” was co-organized by the Sasakawa Peace Foundation and the above two organizations last February. In this Symposium, the need to develop grievance mechanisms in line with the Engagement & Remedy Guidelines was recognized among the participants. This was based on the fact that Japanese business have still to promote access to remedy, which is one of the three pillars of the UN Guiding Principles on Business and Human Rights.

The purpose of this Forum is to maintain and enhance this momentum which was established through the above Symposium. After last year’s Symposium, there were two major developments. The first one is that the Japanese Government launched the “**National Action Plan on Business and Human Rights (2020-2025)**” (NAP) in October 2020. The other development is that the “**Engagement and Remedy Project**” which aims to implement the Engagement & Remedy Guidelines, especially the Grievance Center Guideline, was launched by the co-organizers of this Forum. This Forum provides the latest findings and good practices about grievance mechanisms in and outside of Japan, as well as discusses the roles that the NAP and the Engagement & Remedy Project will play in terms of promoting grievance mechanisms.

In this Forum, we invite **Professor John Ruggie**, *former UN Special Representative of the Secretary-General on the Issue of Human Rights and Transnational Corporations and Other Business Enterprises* for the keynote address. We also invite **Mr. Mikito Toyama**, *director of the Human Rights and Humanitarian Affairs Division, Ministry of Foreign Affairs*. Moreover, we invite distinguished panelists and commentators for this event. We look forward to your attendance.
